- Effective in difficult to defoam high gloss formulations.
- Fast bubble-break versus conventional defoamers
- Effective against Microfoam
- Very good persistence

FoamStar[®] ST 2445 is a defoaming molecule that defoams by a unique mechanism. Unlike conventional defoamers (mineral oil and silicone types), FoamStar[®] ST 2445 defoams on a molecular level. It also has wetting properties not found in other conventional defoamers. FoamStar[®] ST 2445 utilizes the FoamStar[®] ST 2445 molecule compounded with polysiloxanes in a mineral oil-free system. FoamStar[®] ST 2445 is now the most powerful FoamStar[®] ST series defoamer and is very effective in defoaming high gloss paints based on acrylic and styrene acrylic latices.

Dosage FoamStar[®] ST 2445 can be used at levels of 0.25 % to 0.50 % based on total weight of paint depending on the individual paint formulation. FoamStar[®] ST 2445 addition may be equally divided between the grind and let-down stages. Its effectiveness is the same in the grind and the let-down.
